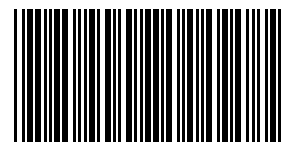

- **Get Transcript Online** – Go to www.irs.gov, click “Get Your Tax Record.” Click “Get Transcript Online.” Follow instructions to set up an account. **And** Request the “Record of Account Transcript”.
- **Automated Telephone Request** – Call 1-800-908-9946.
