Programs of Study

Master Of Science Degree Programs in Nursing

The Master of Science Degree Program in Nursing at the University of Massachusetts Amherst builds on previous nursing education and clinical experience, prepares students the role of Clinical Nurse Leader.

The Nursing Program is accredited by the Commission on Collegiate Nursing Education (CCNE), a national nursing education accrediting body. The School of Nursing program is accredited by the Commission on Collegiate Nursing Education (CCNE).

The Master of Science Degree Program strengthens health care delivery by teaching the advanced knowledge and skills needed to provide comprehensive, across-the-life-span nursing services to individuals, families, and groups. The program's teaching, inquiry, and outreach prepare professional nurses to think critically and reflectively, prepare to serve a culturally diverse population, and manage care autonomously while holistically assessing and treating both health care needs and human responses to illness. The program also promotes social accountability: students are educated and encouraged to work for reform in the health care system at the community, regional, and national levels.

Doctorate of Nursing Practice (DNP)

The DNP program prepares advanced practice nurses at the highest level. The American Association of Colleges of Nursing (AACN), the professional organization for higher education in nursing has mandated a transition from the current Master of Science (MS) degree for advanced practice nurses to the Doctorate of Nursing Practice (DNP) degree by the year 2015. This professional nursing preparation will include advanced coursework in leadership, research translation, clinical knowledge and skills. This proposed change was driven by evolving nursing roles in an increasingly complex health care system, the flood of new scientific knowledge, and ongoing concerns about the quality and outcomes of patient care.

The School prepares DNP graduates in three areas: Family Nurse Practitioner, Psychiatric Mental Health Nurse Practitioner and Public Health Nursing Leadership Specialist. It is a post-Baccalaureate program; however, a post-masters entry is available and involves a review of previous coursework and training through a portfolio process.

Graduates of the DNP program will practice at the highest level. Specific goals of the program are to graduate nurses who will:

- engage in nursing practice using the advanced knowledge from nursing and related disciplines to improve health outcomes,
- provide leadership and collaborate with leaders in other professions for change in systems of care,
- synthesize and translate evidence from nursing and other disciplines to manage complex health problems, and
- provide culturally proficient care to respond to health disparities and societal needs.

Applying to the School of Nursing Graduate Programs

Requirements for Admission

All applicants must meet the general requirements of the University of Massachusetts Graduate School as well as those of the School of Nursing. These include:

- Completion of a Baccalaureate degree from a nationally accredited school of Nursing, or be a registered nurse with a non-nursing baccalaureate degree
- Completion of an undergraduate Health Assessment course, and an undergraduate elementary Statistics course (or equivalents, or permission of program director) *
- Undergraduate Grade Point Average (GPA) of 3.0 (B) or higher - *or* Graduate Record Exam (GRE) if GPA is less than 3.0
- Current licensure as a registered nurse
- Two letters of recommendation
- Where applicable, the Test of English as a Foreign Language (TOEFL) (see http://www.umass.edu/gradschool/prospective_students_GRE_GMAT_TOEFL_exams.htm for more information)
- Written statement of professional goals
- Original writing sample

* Only the Statistics course is required for DNP Public Health Nurse Leader applicants.

Selection Procedure

- Applicants are ranked according to the strength of their qualifications.
- Qualifications which determine rank are: GPA, GRE scores (if needed), recommendations, professional goals, scholarly writing samples and TOEFL for foreign students.

How to Apply

Completed applications are due February 1st prior to the Fall term you intend to enroll*. The applicant is responsible for verifying that the School of Nursing office has received all application materials. Late applications will be forwarded to the following year's application pool.

Application is a two-part process: (1) *First* fill out a University of Massachusetts Amherst Graduate School Application; (2) Fill out *this* application for the School of Nursing, beginning on page 6.

Applying to the University of Massachusetts Amherst Graduate School

To receive a University of Massachusetts Amherst Graduate School Application, you can call (413) 545-0721 – or download an application or apply online by visiting the website at www.umass.edu/gradschool/ . A completed Graduate School Application must include the following:

- ___ Submission of two official (unopened) transcripts documenting completion of a Baccalaureate degree. **Transcripts will be forwarded to Nursing from the Graduate School. You do not have to send double.**
- ___ Two completed recommendation forms (*original* copies only) **Once received at the Graduate School, references will be forwarded to Nursing.**
- ___ Required applicant fee
- ___ TOEFL Scores, if applicable
- ___ Check or Money Order for \$40 (US residents), or \$65 for International students, payable to the University of Massachusetts

Also *recommended*, if your Baccalaureate GPA was less than 3.0:

- ___ Official Graduate Record Examination (GRE) Scores taken within the past five years (if needed)

Applying to the School of Nursing

After submitting your application to the University of Massachusetts Amherst Graduate School, but before the February 1st deadline, submit your completed School of Nursing Degree Application. Please see the application form (beginning on page 6) for details.

- Read all instructions carefully.
- Type or print legibly in ink.
- Complete all applicable information and sign in the appropriate places.
- Enclose all supplemental materials with the application. Faxed materials cannot be accepted.

Notification of Admission Status

Students will be notified by mail of their admission status by the Graduate School and the School of Nursing. Please allow three months after the deadline date for decisions to be made.

Additional materials you must provide following notification

Applicants who are admitted to the Graduate Program in Nursing must provide the School of Nursing with the following documentation by **September 1***:

- Physical exam within the past 6 months
- TB skin test within the past 12 months
- CPR certification within the past year
- Hepatitis B immunization
- Measles, Mumps, Rubella immunization
- Health insurance
- Malpractice insurance

* Note: DNP Public Health Nurse Leader students NOT required to provide this information

Academic Honesty Policy

All members of the University community must participate in the development of a climate conducive to academic honesty. While the faculty, because of their unique role in the educational process, have the responsibility for defining, encouraging, fostering, and upholding the ethic of academic honesty, students have the responsibility of conforming in all respects to that ethic.

American Nurses' Association Code of Ethics

1. The nurse, in all professional relationships, practices with compassion and respect for the inherent dignity, worth, and uniqueness of every individual, unrestricted by considerations of social or economic status, personal attributes, or the nature of health problems.
2. The nurse's primary commitment is to the patient, whether an individual, family, group, or community. The nurse promotes, advocates for, and strives to protect the health, safety, and rights of the patient.
3. The nurse is responsible and accountable for individual nursing practice and determines the appropriate delegation of tasks consistent with the nurse's obligation to provide optimum patient care.

4. The nurse owes the same duties to self as to others, including the responsibility to preserve integrity and safety, to maintain competence, and to continue personal and professional growth.
5. The nurse participates in establishing, maintaining, and improving health care environments and conditions of employment conducive to the provision of quality health care and consistent with the values of the profession through individual and collective action.
6. The nurse participates in the advancement of the profession through contributions to practice, education, administration, and knowledge development.
7. The nurse collaborates with other health professionals and the public in promoting community, national, and international efforts to meet health needs.
8. The profession of nursing, as represented by associations and their members, is responsible for articulating nursing values, for maintaining the integrity of the profession and its practice, and for shaping social policy.
