

PhD in Nursing Program

The University of Massachusetts Amherst PhD in Nursing Program offers a wealth of educational opportunities. The campus is a Carnegie-designated research extensive public university offering more than 70 different graduate programs in 10 schools and colleges. The PhD program builds on previous nursing education. The program consists of courses in nursing knowledge and theory development, nursing research, statistics, advanced nursing electives, cognates and a dissertation.

Graduates of the PhD program will have a strong foundation in inquiry and three major areas of expertise:

- knowledge of the discipline of nursing
- knowledge of a specific clinical or practice population and
- strategies of research and scholarship, such as grant writing and publication

Program Goals

The goal of the PhD Program is to prepare nurse researchers, scholars, and educators who will:

- Advance nursing knowledge and improve nursing practice
- Synthesize knowledge from nursing and other disciplines to address complex health problems
- Be leaders in nursing research and nursing education

To achieve this expertise, students are educated through coursework, seminars, tutorials, grant writing and independent research.

Students work with faculty whose research is mainly centered around three focal areas:

- self/symptom management and chronic illness
- health promotion, disease prevention, vulnerable populations and health disparities
- informatics, patient safety, health care quality and health care systems

Admission Criteria

Admission to the program is based on an overall appraisal of the applicant's ability to undertake doctoral study and of their potential contributions to the discipline of nursing as evidenced in the following:

- Official transcripts from colleges/universities attended
- A master's degree from a nationally accredited school of nursing and grade point average of 3.0 or better, **or** bachelor's degree in Nursing and GPA of 3.2 or better. For international applicants whose GPA is not translatable in their official transcripts, the Graduate Program Director will evaluate and make a decision.
- Graduate Record Examination taken in the past five years
- Two letters of recommendation

- Two examples of scholarly writing (e.g., publications, scholarly papers)
- A research focus congruent with that of a potential faculty research advisor
- Participation in an admission interview

Other criteria for International Applicants:

- Completion of International Student Application (from University of Massachusetts/Amherst Graduate School).
- GPA of 3.0 or equivalent
- Use of translation service for transcript as necessary
- TOEFL scores where applicable

Students are admitted to both the University of Massachusetts Amherst Graduate School and the School of Nursing. Admission priority is given to applications completed and postmarked by February 1. To apply online please visit www.umass.edu/gradschool
