

## **Clery Crime Log**

This log is used to record all crimes reported to UMPD in accordance with the Clery Act.

Non-criminal acts handled by UMPD are NOT listed in this log.

"CSA" indicates a report by a Campus Security Authority (most commonly Residence Life staff or the Dean of Students' Office); these matters are not generally handled by a police response.

## **Crime Abbreviations:**

**A&B** – Assault and Battery

**B&E** – Breaking and Entering

**DW** – Dangerous Weapon

M/V – Motor Vehicle

## **Dispositions:**

OPEN – the listed crime is considered under investigation; no resolution has yet been reached CLOSED – the listed crime is no longer under investigation due to a resolution, or a lack of further leads.

**ARR** – an arrest has been made in the case. **SUMMONS** – a suspect has been charged but not arrested.

**REFERRAL** – the matter has been referred for administrative action

**UNFOUNDED** – investigation has revealed that no crime occurred
