Clery Crime Log

This log is used to record all crimes reported to UMPD in accordance with the Clery Act.

Non-criminal acts handled by UMPD are NOT listed in this log.

“CSA” indicates a report by a Campus Security Authority (most commonly Residence Life staff or the Dean of Students’ Office); these matters are not generally handled by a police response.

Crime Abbreviations:
A&B – Assault and Battery
B&E – Breaking and Entering
DW – Dangerous Weapon
M/V – Motor Vehicle

Dispositions:
OPEN – the listed crime is considered under investigation; no resolution has yet been reached
CLOSED – the listed crime is no longer under investigation due to a resolution, or a lack of further leads.
ARR – an arrest has been made in the case.
SUMMONS – a suspect has been charged but not arrested.
REFERRAL – the matter has been referred for administrative action
UNFOUNDED – investigation has revealed that no crime occurred
