

Clery Crime Log

"CSA" indicates a report by a Campus Security Authority (most commonly Residence Life staff or the Dean of Students' Office); these matters are not generally handled by a police response.

Crime Abbreviations:

DW - Dangerous Weapon

M/V – Motor Vehicle

Dispositions:

OPEN – the listed crime is considered under investigation; no resolution has yet been reached CLOSED – the listed crime is no longer under investigation due to a resolution, or a lack of further leads.

ARR – an arrest has been made in the case. **SUMMONS** – a suspect has been charged but not arrested.

REFERRAL – the matter has been referred for administrative action
